

As NYS PSC Chairman, Bill also served on NYSERDA's Board of Directors and as Chair of the New York State Board on Electric Generation Siting and the Environment. He is a former board member of the New York State Environmental Board, the New York State Disaster Preparedness Commission, and former co-chairman of the New York Telecommunications Reliability Advisory Council. He was appointed by the chairman of the Federal Energy Regulatory Commission as vice-chairman of the federal Joint Board on Economic Dispatch for the Northeast Region.
